

**FIRST COMMUNITY CREDIT UNION “STARS IN THE CLASSROOM”  
CONTEST OFFICIAL RULES**

1. **NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**  
Void where prohibited. Subject to applicable federal, state, and local laws.
2. **ELIGIBILITY:** The Contest is open to legal residents of the Greater Houston area only. Entrants must be age 5 or older and in grades K - 12. Employees of First Community Credit Union, and each of their subsidiaries, affiliates and advertising/promotional agencies, and the immediate families and household members of each, are not eligible. Limit one entry per person for the Contest period.
3. **CONTEST PERIOD:** The Contest period begins at 12am (midnight) on November 1, 2024 and ends at 12am (midnight) on March 31, 2025. The winners will be selected in accordance with the drawing schedule set forth in Section 5 below.
4. **TO ENTER:** To enter the Contest you must complete the nomination information on [FCCU.ORG/STARS](https://www.fccu.org/stars). **Only online nominations will be accepted; no other submissions will be accepted.** You will be asked to submit an essay online (a minimum of 1,000 words in length) nominating your favorite teacher and completing the prompts as instructed (the “Essay”).

The Essay must be completely original and solely your work. You may not copy, plagiarize or base it on anyone else’s work. You may submit only one Essay. If you submit multiple Essays, this will result in disqualification of all Essays submitted by you. Incomplete entries (Essays less than 1,000 words) or Essays exceeding 1,500 words will not be considered. Submission of your Essay means that it becomes property of First Community Credit Union, which will own all rights, title and interest in and to the Essay. No entry materials, including the Essay, will be returned.

You will also be asked to provide only your first name, age, email address and phone number of your parent or legal guardian. **If you are under age 13, you may not submit any personally identifiable information (e.g., full name, street address, etc.) in the Essay or otherwise. If you are under age 13 and submit personally identifiable information in your Essay, then First Community Credit Union shall discard your Essay without maintaining a copy and you shall be ineligible to win the Contest.**

5. **SELECTING THE WINNERS.** Entries will be judged by select First Community Credit Union representatives based upon the Essay. Two winners will be chosen on each selection date. All winners are at the discretion of the SVP, Marketing Director. The decisions of judges are final in all matters. First Community Credit Union reserves the right to modify the selection date and the number of winners for each selection date based upon the number of Essays received. Selection dates are in notated in the drawing schedule on the next page.

The judges shall select winners on the following dates:

The parent/legal guardian and school of the winners shall be contacted via phone or email within approximately three (3) business days after the selection date.

**PRIZES:** Ten (10) prizes comprised of the following:

Each winning teacher shall receive the following:

- A special visit to their classroom by a First Community Credit Union representative.
- \$500 donation made in their honor to the school district
- A personalized crystal award
- \$200 Amazon Gift Card
- Special Gift Basket

Each winning student shall receive the following:

- An invitation join First Community Credit Union to surprise the winning teacher.
- Four (4) pack of tickets to a pre-selected Houston attraction.
